Parties work together to create a lasting solution, rather than opposing each other.

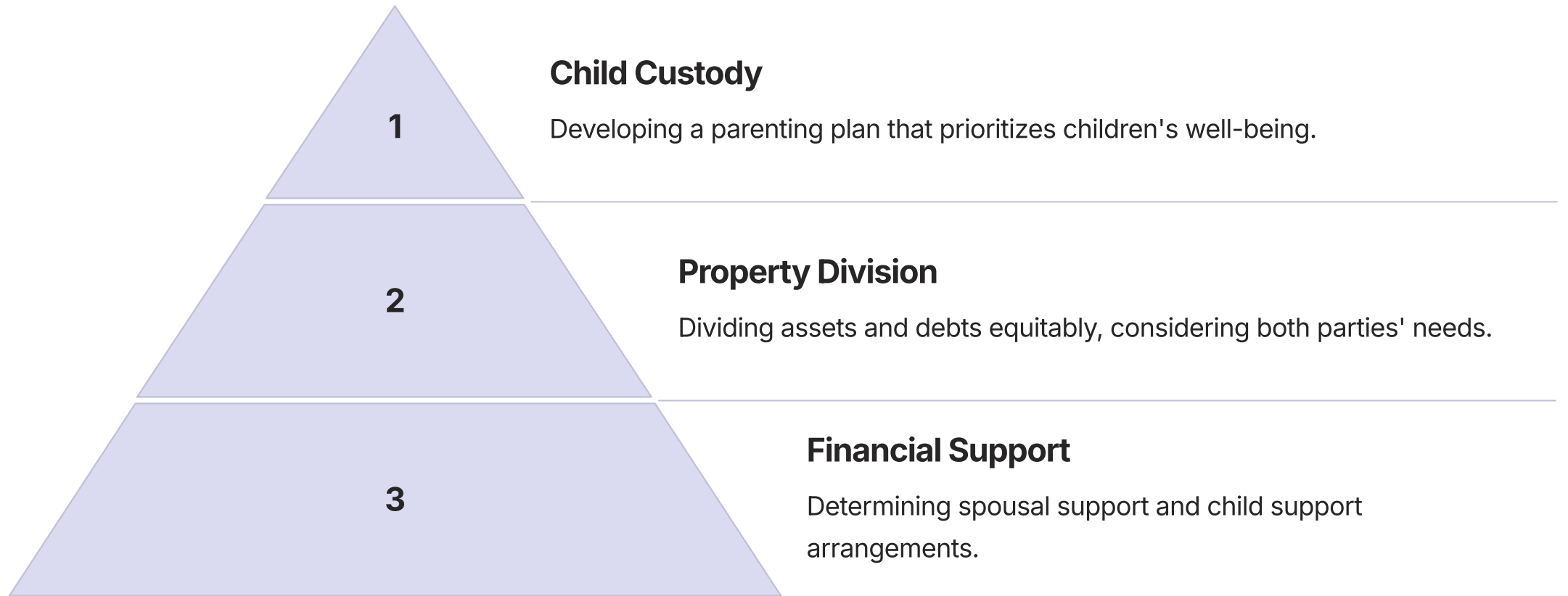
